



**INVITATION FOR PRE-QUALIFICATION [CORRIGENDUM]**

1. Applications along with Proposals were invited for Pre-Qualification by the Executive Engineer B&R Division, C&W Department Astore vide No.EE-Ast/AB/Cash/2023-24/499 dated 11 June, 2024 for the project "**Construction / Widening & Rigid Pavement of Road from Jutay to Kalapani i/c Construction / Realignment of 02 km Road Repelling Point to Shonigai i/c 01 No RCC Bridge 40 Meter Span**" which was uploaded on PPRA website **TS541668E** and the same invitation was published in daily newspapers.
2. The intend of Communication & Works Department Gilgit-Baltistan was to prequalify constructors for the following 02 Packages of works under above project:
  - I. **Package-1:**  
Construction / Widening & Rigid Pavement of Road from Jutay to Kalapani **(RD 0- 11 km)**
  - II. **Package-2:**  
Construction / Widening & Rigid Pavement of Road from Jutay to Kalapani **(RD 12- 19.7 km)**
3. Due to technical reasons, such as minor design adjustments and corrections to the project estimates, a new technical sanction is required. Consequently, the closing and opening dates and times have been extended and rescheduled.

**INVITATION FOR PRE-QUALIFICATION**

1. The Communication & Works Department Gilgit-Baltistan has been entrusted by the Government of Gilgit -Baltistan and provided funds to finance the cost of "**Construction / Widening & Rigid Pavement of Road from Juty to Kalapani i/c Construction / Realignment of 02 km Road Repelling Point to Shonigai i/c 01 No RCC Bridge 40 Meter Span**" to eligible payments under the contract(s) for which this Invitation for Pre-qualification is issued.
2. The Communication & Works Department Gilgit-Baltistan hereinafter the Employer intends to prequalify constructors for the following 02 Packages of works under above project:
  - I. **Package-1:**  
Construction / Widening & Rigid Pavement of Road from Jutay to Kalapani (RD 0- 11 km)
  - II. **Package-2:**  
Construction / Widening & Rigid Pavement of Road from Jutay to Kalapani (RD 12- 19.7 km)
3. It is expected that Invitation to Bid will be issued by July 2024.
4. Pre-qualification is open to constructors/joint ventures of constructors who are registered with PEC in Category C-3 for Construction of Engineering Works, described in para 2 mentioned hereinabove. Applications may be submitted for prequalification for the above 02 Packages of Works.
5. Appropriate category PEC registered constructors may obtain the "**Prequalification Documents**" (having detail terms, conditions, requirements and evaluation criteria for Pre-qualification) from the office of the Executive Engineer, B&R Division, Communication and Works Department Astore.
6. The request must clearly state "**Request for Pre-qualification Documents**" for above mentioned project and package. The documents are available for a non-refundable fee of Pak Rs. 10,000/-
7. A minimum requirement for pre-qualification will be to have successfully completed projects of a similar nature.
8. Applications along with the proposals having complete profile of firm for Pre-qualification must be delivered in sealed envelopes by hand or through registered mail, to:-  
**"Office of the Executive Engineer, B&R Division Communication & Works Department Astore"** not later than **1<sup>st</sup> July 2024 by 11:00 am** and be clearly marked "Application for Pre-qualification" for the packages of the project mentioned above. The applications / proposals will be opened on the same day at **11:30 am**.



Pre-Bid Meeting will be held on 24<sup>th</sup> June 2024 at 2:00 pm at "Office of the Executive Engineer, B&R Division Communication & Works Department Astore".

10. The Communication & Works Department GB reserves the right to reject late applications.
11. Power of Attorney shall not be accepted keeping in view the past fraudulent practices. The owner of firm or JV partners as mentioned in the profile according to the registration in Pakistan Engineering Council shall have to attend the office during opening of proposal / bids and also during other procurement proceedings.
12. Applicants will be informed, in due course, of the result of the evaluation of applications. Only the firms of constructors and joint ventures prequalified under this process will be invited to bid.
