This registration will be for the current financial year 2020-2021.

1. Income Tax Deduction returns for financial year 2019-2020.
2. Bank Statement of last two years.
3. Registration Certificate of last three years issued by Pakistan Engineering Council.
4. Partnership deed (in case of partnership)
5. Registered power of attorney (in case of partnership).
6. An affidavit that the firm has not been blacklisted from any Government Department.
7. An affidavit that firm has not been engaged in any Civil or Criminal litigation with any Government Department.
8. Detail of firm's employee and complete detail of tools, plants and machinery with proof.
9. Attested copy of CNIC of all participant and staff.
10. Detail of works and registration with recent Govt. organizations (for last two years).
11. Applications for eligibility with Deputy Postmaster General Faisalabad Region Faisalabad.
12. The date and time of submission on bids will be informed to the qualified firms in accordance with PPR-2004.
