INVITATION TO BID FOR INSTALLATION OF REVERSE OSMOSIS PLANT FILTRATION PLANT

1. The Utility Stores Corporation of Pakistan (USC) intends to hire register firms for installation of Reverse Osmosis Plants/ Filtration Plants with all related machineries/ accessories of USC brand pure drinking water with the capacity of 5000 litre per Hour. Production line and packing unit to produce healthy drinking water bottles in different sizes 19 litre, 6 litre, 1.5 litre and 500 ml at USC Warehouse 1-9/3 Industrial Area Islamabad. Zonal Building Peshawar and Lahore with Collaboration of Utility Stores Corporation for store and elsewhere as per given criteria in the terms of references (TOR's) as per specification approved by WHO/PSQCA. The participating manufacturers should be registered with SECP/Registrar of Firms, Sales tax and income tax department, PSQCA, PCRWR ISO 9001: 2015. The rates must be quoted per Bottle on prescribed tender form containing terms and conditions/ Specification. The estimated 2% Bid Security of tender is Rs 35,00,000.00.
2. Bids should be submitted electronically only through E-PADS under rule 36 (b) *single stage two envelope of the Public Procurement Rules 2004, for complete procedure for installation to till finish stock (Packing of different Utility brand Pure Drinking Water bottles with packing material (Printed)/packing charges/delivery charges. Manual submission of bids is not allowed.
3. The bids prepared in accordance with the instruction in the bidding documents, must be submitted on E-PADS on 22-01-2025 at 02:00 PM which will be opened on the same day at 02:30 PM through E-PADS. All interested bidders must register themselves on the E-PADS <http://eprocure.gov.pk/#/supplier/registration>. No physical bid shall be entertained. In case of opening of bids falls on local/national holiday, the date of bid closing/opening shall be the next working day on the same time and venue.
4. The bidders are required to give their best and a final price (inclusive of all applicable Taxes) as no negotiations is allowed Bids not complying with the requirements shall be rejected being non responsive Alternate proposals/conditional/ incomplete proposals shall be considered nonresponsive Taxes will be deducted as per applicable Government rules, NTN and Sales Tax Registrations certificates must be provided with the bid.
5. Bids which are not complete/not signed/not stamped/late or submitted by other than specified mode will be rejected. The contract will be awarded to the most advantageous bid on a lump sum contract basis.
6. Bidding/tender documents along with terms and conditions, for bidding can be obtained electronically through E-PADS PPRA website www.eprocure.gov.pk. The envelopes shall be marked as *FINANCIAL PROPOSAL and *TECHNICAL PROPOSAL in bold and legible letters to avoid confusion and also all documents uploaded through E-PADS
7. Bidders need to register at E-PADS PPRA to access the Bidding documents and other relevant information's. The estimated 2% Bid Security of tender is Rs.35,00,000.00 must be attached with the bid in shape of Pay Order/Demand Draft in lieu of provision of bidding documents in favour of USC.
8. An affidavit on legal stamp paper worth Rs.100/- to the effect that the Bidder has not been blacklisted by any Government/Semi Government/autonomous Organisation and there is no litigation is lying pending adjudication in any Court of Law.
