- d. Ventilate the rooms and measure the residual concentration before using the rooms again, it is strictly forbidden to stay in the fumigated rooms.
- e. State Life reserves the right to ADD/DELETE/MODIFY work including varying the quantities of any item as per site requirement.
- f. Contractors are advised to visit the site before quoting their rates.
- g. The job may also be inspected/checked/verified by the SLIC representative for quality control and if found any non-conformity then contractor has to rectify and do the corrective actions at no extra charges.
