


**ISLAMABAD ELECTRIC SUPPLY COMPANY

IESCO intends to hire registered security company for providing security guards retired from Defence Forces, Fighting Arms, Artillery, Rangers, Police and Mujahid Forces for key points/sensitive installations and government offices/buildings/properties across the area of jurisdiction (District Islamabad, Rawalpindi, Murree, Jhelum, Attock, Chakwal, Talagang and AJK), through this advertisement, IESCO invites sealed proposal from eligible and reputable firm(s) with demonstrable and proven capability of undertaking, managing and executing similar assignments providing including following information:-
  - a. Registration copy of NTN, GST, Income Tax (active tax payer) etc.
  - b. Other terms & conditions mentioned in Bidding Documents.
  - c. Valid No Objection Certificate from Ministry of Interior (GoP) for whole Pakistan.
  - d. Valid membership with All Pakistan Security Agencies Association (APSAA)

3. RFP document will be issued to interested bidder after submission of documents as mentioned above. However, PDF copy of RFP is uploaded on IESCO website for review.
4. The RFP procedure will be based upon "single stage two envelop" method as prescribed under PPRA rules containing separate sealed covers "Technical Proposal" & Financial Proposal".
5. Interested Bidder may seek pre-bid clarification as per timeline thereon in the RFP in writing.
6. RFP shall be accompanied with Bid Security amounting to Rs. 2,000,000/- (Rupees Two Million only) in favour of CEO, IESCO, valid for 28 days beyond bid validity. The bid shall be valid for 180 days. Further Original Bid Security in shape of DD/CDR/Bank Guarantee will be attached with technical proposal.
7. The firm(s) will be selected in accordance with the set forth evaluation and Qualification Criteria of RFP along-with other Terms and Conditions. Interested bidders fulfilling the above requirements can obtain Tender Documents (RFP) from Office of the undersigned at a price of Rs. 5000/- (Rupees Five Thousand only) each (non-refundable).
8. Sealed Proposal is required to be submitted to the undersigned on or before **24<sup>th</sup> February, 2025 at 1100 Hrs.** Technical proposal shall be opened on same day at 1130 Hrs. Financial proposal shall remain unopened in custody of the undersigned. Financial proposal shall be opened only of those bidders who successfully meet minimum passing technical score. Financial proposal of un-qualified Firms shall be returned un-opened.
9. Bids received after the Date and Time specified above shall not be accepted.
10. Electronic bid shall not be accepted.
11. IESCO reserves the right to accept or reject all proposals at any time according to PPRA Rules 33(1).
