Tender for Removal of Airline Refuse/ Garbage

Pakistan International Airlines Corporation, the national flag carrier invites sealed bids for collection of Airline's Refuse/ Throw away Material from PIA Flight Kitchen, Engineering and other PIA location at International Airport Lahore will be held on <u>25-02-2025</u>. The bids prepared Envelops duly marked "Tender for Daily Collection of Airline Refuse/Throw-Away Material" in accordance with the instructions in the bidding documents must be dropped in "Tender Box" "at office of Manager SCM PIA Complex Lahore-Pakistan".

Sealed tenders are invited from the interested vendors registered with income tax office, for contract period of one year and extendable for two terms.

The Vendor will arrange collection of the said refuse through his labor on daily basis irrespective of weekdays/ holidays, round the clock especially from PIA Flight Kitchen FSD Lahore. The vendor will be required to have the area wash after collection and to clean wastage spread on the floor thereafter daily basis. Contractor's staff will be required to report in Uniform with a badge of their company for prompt identification.

Collection of Airline refuse/ throw-away material will be collected from the premises/ locations mentioned below at Lahore Station.

• Catering, Engineering, Apron, TGS Workshop, cargo, Medical Center at Airport Lahore.

WASTE ITEMS TO BE COLLECTED: -

- Throw-away food items, cooked and raw (not useable by PIA)
- Disposable bags, broken plastic, used paper cups, discarded bottles, broken glasses.
- Unserviceable cardboard boxes and unserviceable damaged crates.
- Used Aluminum Casserole and Meal Foils.
- Old Newspapers/ Magazines/ Out dated Hamsafar Magazine.



• All disposable items received from all domestic and international flights handled by PIA.

SPECIFIC TASKS AND SCOPE OF SERVICE: -

• Garbage collection should be conducted on daily basis at all premises.

MODE OF QUOTATION:

• The rates should be quoted on monthly basis.

ENHACEMENT OF AMOUNT:

• The contract will be valid for one year and extendable for other yearly two terms, the first term extension amount will be enhanced by 25% of bid quoted value and 2nd term extension amount will be enhanced by 25% of the preceding term amount.

OTHER TERMS AND CONDITIONS:

- 1. The collected Airline refuse/ throw away material will be taken in such a way that it could not attract birds and burnt/ earth covered combustible item immediately at least five miles away from either ends of the run way of each Airport at the place approved in consultation with Civil Aviation Authority.
- 2. Refuse garbage at each of the above locations would be picked up under supervision of Manager Office Services, (Works Department), PIA Security staff and the supervisor in charge of the respective shop/ section of duty.
- 3. PIA reserves full right to remove, cannibalize or pick up and material erroneously throw or carry out physically checked by unloading trucks before removal of the refuse by the contractor.
- 4. Prospective bidder will be required to submit their sealed quotation along with Earnest money (refundable) @ PKR= 200,000/- and Rs. 10,000/- as tender fee (non- refundable) in the shape of pay order in favor of Pakistan International Airline.
- 5. The Earnest money and Tender fee should be submitted with technical Bid Documents. Tender without Earnest Money shall not be entertained and will be rejected, however performance bond of 15% of total Bid (Refundable) can be asked in the shape of Pay order/ Bank draft by successful bidders.



- 6. The installation, repairing and maintenance of all compactors is the responsibility of the contractors.
- 7. In case of un-satisfactory performance during the contract period, contract will be terminated and other arrangements shall be made at your risk and cost.
- 8. Successful bidders will have to enter into formal agreement with PIA on a non-judicial stamp paper.
- 9. Advance Monthly payment will be deposited latest by 30th of the preceding month with cashier PIA Lahore Airport on shape of cash including all taxes payable to the Government.
- 10. The offer should be valid for 90 days for acceptance after opening of the tender.
- 11.PIAC reserves the right to accept/ reject any or all tender(s) divide business among parties or extend the date of opening with assigned reason.
