- (iv) In proof of experience the contractor is required to submit at most 02 No. valid work orders having cumulative cost equal to or more than 100% of BOQ amount along with work completion certificates obtained from work order issuing authority for executing for same nature of work during the last 05 years.
- (v) Joint Venture is not applicable.
