Bids should be submitted in sealed envelopes, delivered at the O/o Director (C&P), TDP, Tarbela on or before 1100 hours on 25.06.2024 and must be accompanied by a Bid Security of Rs. 100000/- (**One Lac**) for above mentioned procurement in the form of unconditional Bank Guarantee (on prescribed form of Bid Security in the bidding document) or in the form of CDR in favor of GM & PD, TDP

Bids will be opened on the same day at 1130 hours in the presence of the bidders or their authorized representatives who choose to attend at the O/o Director (C&P), Tarbela Dam Project.

This procurement will be carried out as per PPRA rules, 2004(single stage -one envelope) as amended time to time.

The Employer reserves the rights to accept or reject any or all bids or proposals at any time prior to acceptance of a bid.
