- 2) Bids should be submitted on 25<sup>th</sup> September, 2024 before 10:30 A.M. The same will be opened at 11:00 A.M. in the presence of the bidders. Any bid received after the deadline shall be rejected and returned to the bidder unopened.
- 3) Interested bidders must visit the Senate Secretariat for a physical inspection of the auction items. The detailed terms and conditions alongwith a list of items can be downloaded from the websites of the Senate Secretariat (www.senate.gov.pk) and PPRA (www.ppra.org.pk).
- 4) The bidders are required to submit their sealed bid as per proformas attached in a single envelope containing the following documents:
