The method of payment will be direct deposit under Federal Government of Pakistan Head of Account C-03870-Non Tax receipts-others on Challan 32-A either in the State Bank of Pakistan or National Bank of Pakistan. Interested bidder, who wishes to receive the bidding documents through courier should provide an additional amount of Rs.300/= for delivery within Pakistan.
2. The bidder shall furnish earnest money in the shape of a Pay Order, equivalent to 3% of the estimated value of their bids, in favour of the Chief Commissioner, Medium Taxpayers Office, Karachi.

7. The bidder should submit a copy each of NTN Certificate, Sales Tax Registration/SRB Certificate and CNIC (if applicable).
8. Prices must be quoted in Pakistani currency and should be inclusive of all taxes such as Sales Tax, Income Tax, Sindh Sales Tax on services and duties etc.
