2. Detail list of items as per above mentioned Lots can be obtained from the office of Deputy Director (Admin) NHA (Punjab-South), Nag Shah Chowk (N-70), Multan on any working day during office hours till 28.10.2019. Above mentioned Lots can be seen on any working day during office hour upto 28.10.2019.

3. Lot-Wise Public/Open Auction will be held at 1130 hours on 29.10.2019 “as is where is basis” at NHA Regional Office, Nag Shah Chowk (N-70), Multan.

4. Pay Order/Demand Draft amounting to Rs 25,000/- (Rupees Twenty Five Thousand only) in favor of GM (Maintenance) NHA (Punjab-South) Multan, shall be submitted by each participant along-with copy of valid CNIC, as Expression of Interest/token money (**Refundable**) on 29.10.2019, failing which the bidder shall not be allowed to participate in public/open auction.

5. The successful/highest bidder shall have to deposit 25% of the highest bid amount at the spot **for each Lot** as earnest money (**Non Refundable**), failing which the bid shall be rejected, token money of such bidder shall be forfeited and auction process shall be continued. All applicable Government Taxes will be charged in addition to highest bid amount.

6. The successful/highest bidder shall have to deposit the remaining 75% amount within 10 (Ten) days after approval of the bid by the Competent Authority. In case successful bidder fails to deposit remaining 75% amount within the prescribed time, the token and earnest money of such bidder shall be forfeited and NHA may re-auction the dead stock at its will. No claim whatsoever of such bidder will be accepted by NHA.

7. The successful/highest bidder will be accorded written permission for removal of dead stock from the concerned location within specified time after depositing full payment including all applicable taxes. If the successful bidder fails to remove the dead stock within specified time, 5% of bid amount shall be charged as ground rent up-to period of 15 days and thereafter the whole amount will be forfeited and NHA may re-auction the dead stock at its will. No claim whatsoever of such bidder will be accepted by NHA.

8. Queries (if any) can be cleared at the spot, thereafter, no objection shall be entertained and decision of Auction Committee in case of any dispute shall be final.

9. NHA reserves the right to reject all bids or proposals in accordance with the PPRA Rules.
