

STORE ITEMS OF NATIONAL SPECIAL EDUCATION CENTRE FOR HIC**

The National Special Education Centre for Hearing Impaired Children (NSEC for HIC) invites sealed bid on lump sum basis on prescribed proforma as per **Annex-I**, from interested individuals/parties for auction of its used store items etc., as per list at **Annex-II**.

General Terms and Conditions:

1. The old/used scrapped items of stores will be auctioned through sealed bid on the basis of "As is and where is" and as total highest basis.
2. The bidder will be required to submit the bid for all store items as per **Annex-II**, on lump sum basis, partial bid will not be accepted.
3. The bidder will be required to submit a **Pay Order** equal to **5%** of the total value of the bid as earnest money in favor of DDO NSEC for HIC payable at Islamabad.
4. Any bid without earnest money or with any condition shall be rejected immediately after opening by the Auction Committee.
5. The successful bidder will be required to pay an amount equal to **20%** of total bid money (in cash or through the challan in State Bank of Pakistan or National Bank of Pakistan), before closing of the working hours of the next working day and balance amount will be payable within five (05) working days through the challan in State Bank of Pakistan or National Bank of Pakistan, otherwise the bid will be cancelled and its earnest money as well as 20% advance shall be forfeited.
6. The pay order of 5% earnest money will be released to the bidders after the payment of entire amount of bid and removal of the store items.
7. The successful bidder will remove the relevant store items immediately at his own risk and cost, after depositing the full payment within seven (07) days.
8. The successful bidder will be required to pay with-holding tax imposed by the Government i.e. 11% in case of filer and 22% in case of non-filer, and other taxes of the government if applicable.
9. The bids are required to be delivered to the office of the undersigned by 10:30 am on 27 December, 2024. The Auction Committee of NSEC for HIC will open the bids in front of the bidders or their authorized representatives for further process on same day at 11:00 am and will disclose the reserved price of the total store items in the presence of the bidders, or their authorized representatives, who may like to be present at National Special Education Centre for HIC Building situated at Plot No.27, H-9/4, Islamabad.
10. The NSEC for HIC reserves the right to reject the offered bid less than the reserved price of entire auction items.


