



TENDER NOTICE

GEPCO invites the tenders for engagement of consultancy services from PEC registered engineering consultancy firms verification and testing of the earthing systems for HT/LT Steel Structures & Round Steel Poles across GEPCO's operational areas, as per clause 36(b), Single Stage-Two envelopes Procedure of PPRA rules 2004.

The scope of work for the selected firm will include:

(i) Visual Inspections:	To conduct 100% visual inspections of all earthing systems for all HT/LT Steel Structures & Round Steel Poles to identify visible defects or deviations
(ii) Resistance Testing:	To measure earthing resistance values using latest digital earth resistance meter of 100% HT/LT Steel Structures & Round Steel Poles
(iii) Reporting:	Provide detailed reports of inspection and testing results, including visual evidence and recommendations for corrective measures.
Approximate Quantity of Poles to be verified and tested:	
223,583 No. of HT/LT Steel Structures & Round Steel Poles	

- The required documents to be submitted along with the proposals are as under;
 - Certification of registration with PEC along with latest renewal.
 - List of professional staff along with their CVs showing project wise experience with exact time of duration of each project.
 - List of similar services provided by the firms during the last 05-years and works in hand indicating total cost of such works and cost of consultancy and expected date of completion.
 - A certificate/affidavit that the firm is not Black Listed by Government/Authority and not involved in Litigation with any Govt. Department/Authority.
 - Financial statements of the firm (at-least for the last 03-years) along with Bank Balance, detail of credit lines (duly attested by the Sr. Manager of the Bank).
- The duration of consultancy services will be 01 year.
- The RFP will be available up to **27.02.2025** at 1630 hrs from the office of Chief Engineer O&M(Dist.) GEPCO on the payment of the non-refundable fee **Rs. 5000/-** Pre-bid meeting (if any) will be held on **26.02.2025** at 1400 hrs in the office of Chief Engineer O&M (Dist.).
- The Technical and Financial proposals must be submitted in the office of Chief Engineer O&M(Dist.) GEPCO H/Q, 565/A Model Town Gujranwala on **28.02.2025** up to 1130 hrs and the same will be opened on the same day at 1200 hrs in the presence of authorized representatives of the firms.
- The Technical and financial proposals should be valid for **120 days** from the date of opening of technical proposal and should be sealed in separate envelopes clearly mentioning the category of the proposal and both these envelopes should be enclosed in another envelope clearly mentioning the name of the consulting firm/company. The bid security **Rs.2,000,000/- (Two Million)** in the shape of CDR/Bank guarantee should be enclosed in the Technical proposal's Envelope also.
