2. Only Sales Tax Registered Firms/Suppliers can participate. Taxes shall be deducted as per Government rules amended from time to time.
3. Tenders received after due date & time shall not be entertained.
4. Estimated Cost of this procurement is **Rs. 800,000/-**.
5. Bid Security amount (Earnest money) of **Rs.40,000/-** (including taxes) in the shape of CDR/Pay order favoring “**State Life Insurance Corporation of Pakistan**” must be submitted by the bidders at the address given in tender notice / documents before closing date & time, otherwise bid will be rejected.
6. Bid Security will be returned to un-successful bidders after completion of tender.
7. Bidders are required to upload their bids on EPADS system as per laid down PPRA procedure for **Single Stage Single Envelope** method with title as “**Air conditioner Services/Repair/Maintenance required**”.
8. Competent Authority reserves the right to reject any/all items or any/all bid(s) or proposals at any time before award of contract.
9. The quoted price must be inclusive of all applicable taxes as per Government Rules.
