- Contractors shall provide 3% earnest money E/M Clearly Mentioned the Name of firm in Shape of CDR from any Schedule bank of Pakistan in the Name of **DEPUTY DIRECTOR WATER MANAGEMENT AND IRRIGATION DISTRICT DIAMER.**
- Tender Document shall not issue to Govt. Contractors involved in Litigation in any Government organization or having Sick/Delayed Projects.
