INVITATION FOR PREQUALIFICATION

Quaid-i-Azam Mazar Management Board, National Heritage & Culture Division, Ministry of Federal Education, Professional Training, National Heritage and Culture, Government of Pakistan, which is responsible for maintenance and development of Quaid's Mausoleum and Bagh-e-Quaid-i-Azam including Peripheral Area and its allied buildings. Quaid-i-Azam Mazar Management Board is planning for upgradation of Aiwan-e-Nawadrat-e-Quaid-i-Azam (ANQA) situated at Quaid's Mazar, Karachi.

Quaid-i-Azam Mazar Management Board, National Heritage & Culture Division, Government of Pakistan invites sealed proposals for prequalification of interested Organizations/Firms/Joint Ventures/NGO's/Trust/ etc., for the "**Provision of Curatorial Services for Aiwan-e-Nawadrat-e-Quaid-i-Azam and design of archival museum exhibits**". The existing Museum is to be renovated with its existing exhibits and show cases upgraded, incorporating digital technology to create an educational and interactive space to engage visitors. The interested bidders must be duly registered with Income Tax & Sindh Revenue Board (SRB) and must be on FBR's Active Tax Payer's List (ATL).

Prequalification documents can also be downloaded from www.qmmb.gov.pk (in case of download from website, the cost of prequalification documents in shape of Pay Order is to be submitted with the Prequalification Application).

3. The Prequalification Documents can be obtained from Office of the Resident Engineer Quaid-i-Azam Mazar Management Board, Karachi till 27th January 2022. Prequalification Application can be submitted till 28th January 2022 before 11:00a.m. The applicants shall be informed of the results of the prequalification process within 07 days of last date of submission of bids. Bidding Procedure will be carried out in accordance with Rule 36(c) of PPRA Rules, 2004.
