- 1) Interested bidders can only submit their bids online through E-Tender Portal of ML& C Dept. (https://etender.mlc.gov.pk).
- 2) Contractors having valid NTN No, STRN No. are eligible to apply.
- The cutoff time for submission of online bids will be 1200 hrs dated 20 / 11 / 12024 and shall be opened on same day at 1400 hrs electronically on the portal. The contractors will be able to see the comparative statement online.
- 4) E-tenders without attachment of call deposit / bid bond in favor of the undersigned equal to the earnest money will be rejected.
- The CDR's/Bid Security/earnest money (2% of bid amount) uploaded online shall also be deposited (in original) in LCB office (CB Care Centre) on the same day prior to cut off time in shape of demand draft/CDR/Pay order before opening of bids as per PPRA Rule No.25. In case of failure the bidder shall not be qualified for bid opening and shall be liable to face the consequences of forfeiture and blacklisting for sabotaging the tendering process.
- 6) The bid security/earnest money of successful bidder will be refunded after expiry of defect liability period i.e. 01 year after completion of work OR successful completion of audit which ever later.

- 7) In case if the lowest bid is less than reasonable rates, the lowest bidder shall have to deposit performance guarantee (refundable after successful completion of the work) 6% of bid amount in the shape of Bank Guarantee from any Schedule Bank in Pakistan or insurance bond from reputed insurance company which shall be got approved from the LCB (in addition to earnest money) within 07 days after issuance of acceptance letter as per PPRA Rule, 39. In case of failure the already deposited earnest money shall be forfeited and tender will be cancelled.
- 8) The Cantonment Board reserves the rights to demand the analysis of quoted rates of check their reasonability and workability.
- 9) The successful contractor shall enter into a prescribed agreement (at their own cost on non-judicial stamp paper) with the CB Lahore within 07 days of issuance of acceptance letter.
- 10) The Cantonment Board / Executive Officer reserve the right to reject the tender as per PPRA's Rule No. 33 (I) due to any reason thereof.
- 11) The issuance of work order shall be subject to approval from Board.
- 12) The validity of tender rates shall be upto 180 days as per PPRA /PEC Rules.
- 13) Any tool/machinery kind of store /mobilization advance for execution of job will not be provided by LCB.
- Any information regarding the e-tender can be obtained from the office of undersigned during office hours. Furthermore, guidance tutorial has been uploaded on the portal.
- 15) No cheque/cash will be acceptable.
- 16) Conditional/multi-optional quotation will not be accepted.
- 17) All PPRA Rules and Govt. taxes (in vogue for the time being) are applicable.
- 18) Overall rate of bid will be considered as lowest instead of single item rate.
