- 7 Only eligible contractors duly registered and renewed with PEC FY 2024-25 as per technical and financial categories mentioned in bidding documents can participate.
- 8 10% performance security as per letter of acceptance will be deposited by successful bidder within 14 days in shape of bank guarantee/pay order/CDR otherwise his deposited CDR will be forfeited and work will be awarded to next lowest bidder. **Insurance guarantee will not be accepted as performance guarantee.**
- 9 Contractors who have not started previously awarded work of this office without any cogent reasons, are not eligible for participating in this tender works
