TERMS & CONDITIONS

- As per rule 36(b) of the PPRA Rule, single stage Two Envelope procedure will be adopted, the bid shall comprise single package which contains two envelopes each envelope shall contain separately the financial proposal and the technical proposal.
- The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion.
- Initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened.
- The envelope marked as "FINANCIAL PROPOSAL" shall be retained in the custody of the PESCO IT Directorate without being opened.
- The financial proposals of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance.
- Fee quoted should be inclusive of all kinds of taxes.
- Detailed terms and conditions will be mentioned in bidding/tender documents.
- The prices should be firm and final without involving any foreign exchange.
- Tender must be accompanied by bank guarantee for an amount not less than 2% (two percent) of total tender value to be valid for 90 days in the form of bank guarantee/call deposit or pay order issued by any scheduled bank of Pakistan.
- Tender form can be obtained from the office of Manager IT PESCO against non-refundable amount of Rs. 5000/- per tender on any working day during office hours till a day earlier from the opening of the tender.
- Tender will be received manually and will be dropped in tender box at the date and time mentioned above however a representative should be present at the time of opening date and time. The bidder must ensure that their bid was dropped in tender box well in time.
- There will be no sale of tender on the date of opening of tender.
- Copy of registration with sales tax department should be produced at the time of issuance of tender documents and with your bid schedule.
- Conditional tender/bid will not be accepted.
