  - a) The Bidder or its proposed Manufacturer must have at least 05 years design / manufacturing experience of similar Goods of the respective Lots with similar or higher rating and capacity.



- b) The Bidder or its proposed Manufacturer shall have manufactured and supplied similar Goods of similar or higher rating and capacity in the quantities at least equal to the 100% quantities during the last ten (10) years in a single or multiple contracts. The Goods supplied by the bidder should have been in satisfactory operation for a continuous period of at least three (3) years on the date of bid opening for Lots 1-6 & of at least One (01) year on the date of bid opening for Lots 7-8. In case of JV, all partners combined should fulfill this requirement (draft JV agreement should be provided with the bid). The bidders, who are not manufacturers themselves, shall furnish an authorization from the concerned manufacturer to submit a bid for supply of their Goods to LESCO in Pakistan against this bid.
- c) The bidder should have sound financial status. The difference between cash in hand and short-term liabilities should be adequate enough for smooth execution of the subject contract. The bidder's net worth calculated as a difference between total assets and total liabilities must be positive for last 03 (three) years.
