

REQUEST FOR PROPOSAL (RFP-28/2025)

(Single Stage Single Envelope)

IESCO intends to Invite Sealed Bids from Government Entities/Semi-Govt Entities/Private Entities involved in the business of Goods transportation for the following: -

SHIFTING OF 132/11KV 20/26 MVA POWER TRANSFORMER FOR AUGMENTATION WORK ON 70 TON PRIVATE TRAILER FROM NEW WAH STORE TO 132 KV GSS PLANDRI & SHIFTING BACK OF 10/13 PTF (DISMANTLED) FROM 132 KV GSS PLANDRI TO NEW WAH STORE UNDER 7TH STG PROJECTS.

ELIGIBILITY:

- Bidders/ Goods Transport Company must demonstrate experience regarding shifting of Goods inter provincially in Pakistan for the last **two (02) years**.
- Bidders/ Goods transport Company must have In-house/ attached transportation facilities such as Heavy Duty Trailers, Cranes and trained personnel's for loading/ unloading at both 132kV Grid Stations. For the purpose, Transport Company shall provide the detail of attached or self-owned heavy duty vehicles & Crane in the bid.

TERMS & CONDITIONS:

1. Eligible Bidders/ Goods Transporters may obtain further information, inspect, and acquire the Request for Proposal (RFP) from the Office of undersigned.
2. A complete set of Request for Proposal may be purchased by interested bidders on submission of a written application at the address mentioned below and upon payment in Cash /Bank Draft /Pay Order of a non-refundable fee of **Rs.2000/-**per document in working hours (**1000 Hrs to 1500 Hrs**).
3. Bidders/ Goods Transporters shall accompany a bid security amounting to **Rs. 42,000/-** in favour of Chief Engineer (Development) IESCO, Islamabad in shape of DD/PO/CDR/Bank Guarantee valid for **28 Days** beyond Bid Validity. Bid shall be valid for a period of **Sixty (60)** days.
4. Bidders/ Goods Transporters shall quote for all items of tender, in case a bidder does not quote complete tender (i.e. all items of the tender), the bid shall be considered non-responsive.
5. Bidders/ Goods Transport Company shall be responsible for safely carriage of Power Transformers from sites to destination. In case of any theft, robbery, accident, damage or fire of material, goods transporter shall pay 100% cost of material to IESCO. For the purpose, Transport Company shall ensure insurance coverage of each item upto 100% of cost of item. 100% insurance coverage shall be in the name of procuring agency.
6. Bids must be delivered to **Chief Engineer (Development) IESCO, Islamabad, Street No 40, Sector G-7/4, Islamabad** on or before **10:00 Hour, 23th May, 2025 (Friday)** and bid will be opened at **10:30 Hours** on the same date in the presence of participants or their authorized

representative (bearing authority letters) who choose to attend Chief Engineer (Development)
IESCO Head Office G-7/4 Street No. 40, Islamabad.

7. The period for completion of work is **30 days**.
8. In case there is holiday on opening date, Tenders will be opened on very next working day.
9. IESCO reserves the right to accept or reject all the bids as per PPRA Rule-33 (1).
