

# IESCO CORRIGENDUM

## TENDER NOS. IESCO/PMU/GOODS/NCB-160,161,162

2. IESCO Project Management Unit (PMU) has reserved the funds for the procurement

- planned during financial year 2024-25. It is intended that part of the proceeds of the funds will be used to cover eligible payment under the contracts for the above procurements.
3. The undersigned now invites sealed bids from eligible bidders for supply of above material.
  4. **Qualification & Experience**
    - i. Bidder/JV must demonstrate two (02) No. of contracts that have been successfully completed within last Five (05) years similar to the proposed work. The value of each Contract Agreements / Work Orders shall be equal to **amount as mentioned in Para-1**. For the purpose, the bidder/JV shall provide relevant Work Orders/Contract Agreements & Completion certificates etc. Bidder/JV must also demonstrate satisfactory performance of the completed works.
    - ii. The Bidder/JV shall demonstrate financial soundness as mentioned above, however detailed terms and conditions are mentioned in **Appendix-A of BD**
  - iii. Manufacturer will demonstrate at least five-year experience of designing and manufacturing of similar material / equipment and three-year satisfactory operational performance from date of submission of bid.
5. The bidding shall be conducted in line with the Single Stage Two Envelope procedure of the Public Procurement Rules – 2004 (amended to-date), Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time), and is open to all potential bidders.
  6. All bids must be accompanied by a Bid Security in favor of General Manager (Development) in an acceptable form mentioned in ITB in the amount fixed in **PKR valid for 28 days** beyond bid validity period and validity of **bid is at least 75 days** from date of submission of bid.
  7. The original bid along with one copy, properly filled in, and enclosed in sealed envelope(s) must be delivered through courier or physically to the Office of General Manager (Development), IESCO Headquarters, Street # 40, Sector G-7/4, Islamabad on or **before 12<sup>th</sup> June, 2024 at 1100 Hrs**. The Technical bids will be opened on **same date at 1130 Hrs** thereafter in public and in the presence of bidders' representatives who choose to attend during the opening at the address mentioned below. However, price bids shall be kept in custody of procuring agency until announcement of results of technical bid evaluation. Price proposal will be opened of those bidders (s) who are declared technically responsive bidder (s) and financial proposal of non-responsive bidder (s) shall be returned unopened to authorized representative of bidder (s).
  8. Interested bidder(s) / firm (s) may visit IESCO website for scrutiny of bidding documents, however bidder will submit their bid(s) after purchase of bidding document from office of the undersigned on request after payment of non-refundable fee of **Rs.5,000/-** for participation on any working day during office hours or may be sent through Courier if requested by the bidder with an additional fee of **Rs. 1,500/-** per document.
  9. Late submission of bid will not be entertained.
  10. IESCO reserves the right to reject the bids as per Rule-33 (1) of PPRA Rules-2004 (amended to date)
  11. Electronic bids are not acceptable.
