Pre-qualification process will be conducted as per rules 15 & 16 of Public Procurement Regulatory Authority (PPRA). Last date for submission of Pre-qualification documents / Tenders is 31st July, 2024 (Wednesday) by / before 1100 hours. NUMS will not be responsible for any postal delays whereas documents sent through email shall not be accepted.

Envelops shall be opened by the Tenders Opening and Evaluation Board / Committee of Experts on same day of closing at/after 1130 hours in front of all participating firms / Contractors or their authorized representatives, (who may choose to witness / present) in Seminar Room, Crown Complex, NUMS PWD Campus, Police Foundation-Islamabad.
- 4. The shortlisted / qualified firms will be informed in due course of time as and when required. The qualified firms / contractors will be invited for the submission of financial bids / quotes through Request for Proposals (RFPs) to compete with other bidders.
- 5. Interested Firms / Contractors must ensure submission of required documents / business details indicated in the prequalification criteria / registration forms. Documents received without valid documentary evidence, supporting documents and various requirements mentioned in the prequalification criteria are liable to be rejected. Valid documentary evidences for the critical components should be submitted by the firm for scrutiny. No objection/revision/supplement shall be

entertained regarding the terms and conditions of the prequalification documents submitted by the firms.

6. Competent authority in NUMS reserves the rights to accept or reject any or all firms applied on the basis of technical or any other grounds or cancel the whole process of prequalification as per Public Procurement Rules 2004.
