



AUCTION OF VEHICLES

Following vehicles will be sold through open auction on "as is and where is" basis on 30th September, 2019 (Monday) at 1100 hours in the office of undersigned in Election Commission of Pakistan Secretariat, Constitution Avenue, G-5/2, Islamabad:

2. Vehicles can be inspected during office hours i.e. between 0900 hours to 1600 hours on any working day upto 29th September, 2019.
3. Security amount for vehicles, equivalent to Rs.50,000/- in shape of Bank Draft/Pay Order in favour of DDO, Election Commission of Pakistan will have to be deposited before taking part in the bidding which will be refunded to unsuccessful bidders on spot.
4. The successful bidder will have to provide National Identity Card and to deposit quarter (1/4) of the total bid amount as earnest money on the spot. In case, the bidder fails to do so the security amount, deposited already in favour of Government will be confiscated, while the offer for auction of said bidder will stand cancelled.
5. The successful bidder will be bound to deposit the balance amount of the bid within seven days of approval of offer, after the deposit of ¼ of the total amount on spot. In the event the bidder fails to deposit the remaining amount the security as well as ¼ part of bid already deposited will be seized in the name of the Government.
6. The bidder will pay all the taxes as per Government rates in addition to Bid amount, approved for the vehicle.

8. The undersigned reserves the right to accept or reject any or all the auction process with assigning cogent reasons.
