



**CRITERIA FOR PRE-QUALIFICATION/EVALUATION OF WORKSHOPS AND
TERMS AND CONDITION**

- i. The interested workshops must have 5-years' experience in relevant field.
- ii. Workshop must have capabilities of all types of repair/maintenance, Overhauling of Engine, Denting, Painting, etc. of vehicles.
- iii. Workshops already providing services to Government departments will be given preference.
- iv. Workshop must have capabilities of timely supply of spare parts, tyres and batteries, engine oil etc.
- v. All/any payments (s) will be made through AGPR Sub Office, Gilgit.
- vi. The interested parties must have sound financial positions; proof may be provided.
- vii. Non-black listed certificate or undertaking/affidavit may be attached with bidding documents.
- viii. The Workshop applying for Pre-Qualification will submit Quotations on demand as and when the repair of vehicle will be required.
- ix. This Collectorate reserves the right to adopt/reject wholly or partially any proposal or cancel the pre-qualification process altogether at any stage under PPRA Rules.
- x. The Pre-Qualification of Workshops will be for Financial Year 2024-25, extendable for the next Financial Year i.e 2025-26, if deemed appropriate by the department.
- xi. Only **Gilgit, Rawalpindi & Islamabad** based workshops are eligible to submit their proposals.

TERMS AND CONDITIONS

- i. The workshop on the panel will be bound to carry out the requisite work on immediate basis when vehicle is referred to it even in odd hours, after issuance of work order.
- ii. Substandard work will not be acceptable. Workshop shall be bound to install genuine parts. In case the spare parts replaced are found sub-standard or second hand, the firms shall be struck off from panel and defaulter will be proceeded under the law, including black listing
- iii. Workshop shall be bound to return the replaced/old spare parts and shall be liable to give warranty of each item replaced or repaired. If the same defect arises again during warranty period, the firms shall be responsible to replace it free of cost.
- iv. Confidentiality of all correspondences/matters will be ensured.
