


2. Willing contractors must adhere following instructions:-

 - Sealed bids should be submitted by **18 Nov 24** in the Conf Room of PEMH Rwp.
 - Technical bids will be opened on **18 Nov 24 at 1100 hrs** fol by opening of financial bids in the presence of bidders or their authorizr d representatives.
 - Willing contractors must visit site and obtain bidding docus alongwith nec docus prior bidding during working hrs.
 - Non refundable amount of Pkr 10000 will be deposited to Q Office PEMH to obtain bidding docus
 - PEMH reserves the right to accept or reject any bid.

Note: Contractors shall provide certificate that thay are not involved in any type of litigation with any Govt Department in the court of law.

3. All contactors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit copy of their registration. Contractors not registered with PEC are ineligible to apply.
4. Firms / vendors must have a minimum of 5 years of experience in HVAC System installation and modification, particularly in helath care envoirments.
5. Proven expertise in designing and implementing positive and negative pressure systems as per JCI.
6. Compliance with all relevant health and safety standards.
