2. Contractors who are enlisted with other department like central / proviosnal PWD, QDA, CDA, WAPDA etc may also tender provided that they are approved contractors will furnish the enlistment documents with their applications for issued of tenders.
3. Contractors no enlisted with MES shall deposit 5% of estimated cost as earnest money in any Sch Bank of Pakistan in favor of CMES (A) Quetta and the treasury receipt Bank receipt will be sent along with the application.
4. Tender must be comprised on two envelopes, one contain priced tender and other priced BQs duly seal.

5. If tender of a contractor not enlisted with MES is accepted he shall be required to deposit Rs. 300,000/- as security in the form as demanded by accepting officer. Tenders shall be issued to contractors upto **03 Jan 2024** during office hours.

6. Copies of the conditions of contracts, sch drawing and all other documents connected with the work can be examined / obtained from the office of undersigned.

7. Tender must be quoted on MES Schedule of Rates 2021. Tenders must reach before **03 Jan 2024 on 11:00 Hrs** and will be opened **at 12:00 hrs** on same date.

Accepting authority does have the rights to accept or reject the tender. However Rules 33 (1) will be applicable.
