The interested firms are required to submit their bids through SINGLE STAGE TWO ENVELOPES procedure as outlined in rule 36 (b) of the PPRA Rules, 2004. Each envelope shall contain separately the TECHNICAL PROPOSAL & FINANCIAL PROPOSAL and shall be marked as such in bold and legible letters to avoid any confusion. The bid validity period shall be ninety (90) working days after the bid is received and opened.

#### A. SCOPE OF WORKS:

- Financial evaluation of the project including project cost, revenue estimates, operational expenditure, projected P&Ls, cash flows and balance sheets for at least 05 years.
  - 2. Social Impact survey (SIA).
- 3. Market and need assessment survey for determining project futures such as shopping center, office tower, commercial flats, shops, hotel, food court, leisure facilities etc.
  - 4. Hard & soft landscaping.
  - 5. Recommendations and way forward.

- 5. NTN and financial strength with record of last 03 years audited accounts.

- 7. Working plan and activity schedule.
- 8. CVs of team leader, SIA expert, marketing and financial expert, town planners and architects registered with PEC, legal experts etc duly signed.

#### C. CONTRACT PROCEDURE:

 Financial proposal should be on lump sum basis including all manpower and out-of-pocket expenses and expected payment schedule. All taxes and levies will be applicable as per rules.

#### D. EVALUATION CRITERIA:

The evaluation committee of CBN shall first scrutinize the technical proposal based on evaluation criteria described in bid documents while retaining the financial proposal.

## E. FINANCIAL EVALUATION

- 3. Tender documents can be obtained from the Office of the Cantonment Board Nowshera during the office hours on payment of Rs. 1000/- (Non Refundable) immediately after publication of this notice.
- 4. The bids shall be accompanied by earnest money of Rs. 25,000/- in the shape Pay Order or bid bond in the name of Executive Officer, Cantonment Board Nowshera, and will be attached with Technical bid.
- The quoted rates in FINANCIAL PROPOSAL should be free from any cutting, erasing and overwriting etc.
