- 7. <u>Delivery of Tender.</u> The tender/quotation will be enclosed in sealed cover which will be invariably marked with quotation against tender inquiry no. 2871/1541/ RT-03/Misc Tpt/Proc/ HRF (M) dated 12 Feb 2025 and complete address. The tender if brought by hand, will be handed over to security staff on duty at Gate-5 Heavy Industries Taxila for placing the same in quotation box (available at gate-5). The quotation will not be brought by hand by any firm while visiting the offices of Deputy Assistant Director (Procurement).

- 8. If required endorsements are not made on the envelope, quotation is liable to be disqualified. The quotation will be opened on **03 Mar 2025** *at 1100* hours in the presence of the available representative of the firms in HRF (M), Heavy Industries Taxila. No quotation will be entertained / considered after *1030 hours*, on the aforementioned date.
- 9. Commercial Offers of technically accepted firms only will be opened later on and date of opening will be intimated to the firms accordingly.
