

- b. Firms listed in Utility Departments for the purpose of installation / reading of meters such as Gas Companies, WAPDA, Development Authorities and Private Housing Schemes etc.

- The electronic bids shall be submitted by using EPADS on or before the dates & time as mentioned above in the bidding document. Manual bids, shall not be accepted. E-Bids will be opened on the mentioned dates & time.
- Tender shall remain valid for 120 days after the opening date. Bid Security/Guarantee for fixed amount
 mentioned in bidding documents in light of PPRA Rules (amended to-date) in shape of Deposit-at-Call,
 Bank Draft, Pay Order & Bid Guarantee issued by any scheduled Bank of Pakistan valid for 150 days
 from the opening date of tender in favour of Finance Director MEPCO Multan must accompany with the
 Bid by the bidders.





- The Original Bid Security shall be submitted on or before the deadline for the submission of bids in the O/O Director (Procurement) Distribution MEPCO H/Q Multan otherwise Bid will be rejected.
- The conditional tender will not be accepted. MEPCO reserves the right to reject all bids as per clause 33
