 Departments, and who are on Active Taxpayers list of the Federal Board of Revenue, for supply of uniforms
 and related items to Collectorate of Customs, Islamabad.
- The bidder shall have his own factory/stitching unit in Rawalpindi / Islamabad, with installation of all
 necessary machinery and have relevant experience. The facility may be visited by the Purchaser to ensure
 the availability of machines and skilled staff.

- The Proposal will include a vender profile with necessary details/documents including Name/ Registration Certificate/Certificate of Incorporation, Registration Number, Registered and Mailing Addresses, Contact Information, Name of Authorized Person, Income and Sales Tax Registration Certificates, Proof of being on Active Taxpayer List, List of skilled manpower to undertake the assignment etc.
- The Proposals will not be considered for evaluation if they do not contain prerequisite documents mentioned above.
- Bids will not be considered after due date/time.
- Bids should reach the undersigned by <u>27.08.2024</u> at <u>12:30 hours</u>, or 15 days after the publishing of this advertisement on PPRA website, whichever is later.
- Bids should be attached with pay order in the name of Assistant Collector (HQ) Collectorate of Customs, Islamabad equivalent to Rs.100,000/- as call Deposit.
- Bids shall be opening at 14.00 hours the same day (27.08.2024) in the presence of bidders.
- Successful bidder will have to provide the uniform during the financial year 2024-25 within 15 days after the issuance of purchase orders failing which the amount of call deposit shall be forfeited and order shall stand cancelled.
- The samples of uniform may be obtained/seen from Custom House Officer (HQ) of the Collectorate during office hours and quality of supplied must not be below the given standard.
- The Purchaser at its exclusive discretion may amend the Tender Document to extend the deadline for the submission of the Tender as per Rule–27 of PPRA Rules.
- The Competent Authority reserves the right to accept or reject any tender in line with PPRA Rules; reasons will be communicated to the bidder on request.
- The Collectorate reserves the right to cancel the tender under PPRA Rules. This tender notice may also be seen on PPRA & FBR websites.
