The terms and conditions of Tender for procurement of items are given below: -

- i. The quotations/bids shall be received up to 3rd October-2024 at II:00 am and shall be opened on the same date at II:30 am in the presence of bidders or their authorized representative.
- ii. Complete specifications and details of the items as well as the specific conditions applied against the particular item can be obtained from the office of the undersigned during office hours. (Address: Admn II Section office of the Accountant General, GB office KIU Road Gilgit)
- Quotations must be accompanied by (3%) of the total offered price in the shape of Call Deposit Receipt (CDR) as bid security in the name of DDO Accountant General Gilgit-Baltistan.
- iv. The sealed quotations/bids reached without 3% CDR will not be entertained.
- v. There will be no compromise on the quantity and quality of the items after acceptance of the bid.
- vi. Submission of any false statement/document and concealing of information is likely to disqualify the bidder at any stage of procurement process.
- vii. Bidders must provide an <u>affidavit on Rs. 10 stamp paper</u> that the contractor or his firm has not been blacklisted by any Govt. Organization.
- viii. The contractors/bidders must have their own shop/showroom as well as past experience for supply of such items as mentioned in his bid documents.
- ix. Office of the <u>Accountant General Gilgit-Baltistan</u> reserves the right to <u>accept/reject</u> any of all bidders without assigning any reason before award of contracts.
