Terms and Conditions

- i. The maintenance and services contract shall be granted on the basis of competitive bidding process, specified in Public Procurement Rules, 2004.
- ii. The bidders should be registered with Income Tax and Sales Tax Departments and Sindh Sales Tax, having their own office & phone / fax numbers (if found contrary the tender will be rejected).
- iii. The bidders should not be black-listed by any authority in the past.
- iv. Bidders are required to furnish Security Deposit 5% of their offer, in the shape of pay order or demand draft from a scheduled bank in favour of the Collector, Collectorate of Customs Appraisement (East), Custom House, Karachi. This Security Deposit shall be refunded to the unsuccessful tender participants. The Security Deposit shall be returned to the successful bidder on completion of the tender contract.
- The price shall be offered in local currency and include all duties and taxes and the v. expenses incurred on supplies including transportation, installation, labour etc, where required.
- vi. The tender bid must mention the type of warrantee and after sale services, if any.
- vii. Sealed tender bids on prescribed tender document must be delivered to the address given below on 30.01.2025, before 2:00pm and shall be opened at 2:30pm on the same day in the presence of the participants of the tender or their authorized representatives who desire to attend.

ix. The tender bid must be valid for at least 90 days, after opening of tenders.

The successful bidder shall provide their services within six working days of acceptance of tender and issuance of work order in this regard. The contract period will be for one year, further extendable for the maximum period upto three years in accordance with the PPRA Rules 2004, subject to satisfactory performance.

xi. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

xii. Procuring agencies shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of procurement contract. A copy of the result shall be placed on the notice board of Collectorate of Customs Appraisement (East), Custom House, Karachi.
