- The bidder shall submit through courier / contractor representative 02% bid security sealed in envelope of the estimated cost in the shape of call deposit (original) from scheduled bank before tender closing date and time.
- 4. The tender shall be cast electronically on or before <u>29</u> November, 2024 upto 11:30 pm on the website (https://etender.mlc.gov.pk) and shall be opened on the same day at 12:30 pm in the presence of tenderer or their authorized representative, who may like to be present.
- Conditional tender and tender without call deposit shall not be entertained.
- 6. Cantt Board / Executive Officer reserve the rights to reject the tender as per PPRA Rule No.33 (1) 2004 due to any reason thereof.
- 7. The validity of tender rates shall be upto 180 days as per PPRA Rules.
