The Company now invites bids **through e-Pak Acquisition & Disposal System (e-PADS) (<https://eprocure.gov.pk>)** from eligible Firms for provision of Miscellaneous IT Equipment, duly registered with Taxation departments at Federal, Province & Regions mentioned above and who are on Active Taxpayers List of the Federal Board of Revenue, for delivery of services on **Delivered Duty Paid (DDP)** basis.

The bidding shall be conducted in line with **“Single Stage-Two Envelope”** procedure according to Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.

Bid(s) must be accompanied by a Bid Security of required amount, in an acceptable form as given in the respective bidding document as well as appearing at e-PADS.
