- 1. Pay order/bank draft/banker's cheque of amount Rs.2000/- (non-refundable) in the name of Director General PITAC, Lahore, must be submitted along with bid as Tender participation Fee.
- 2. The bidder may submit the bids of both items or any one item. Options are not allowed. Bidding will be conducted under National Competitive Bidding Procedure as per the provisions of Public Procurement Rules-36(a) <u>Single stage single envelope</u> procedure.
- 3. Bids may be submitted as per conditions set out in bidding documents electronically through federal PPRA EPADS web portal http://eprocure.gov.pk before closing time & date. Manual bids shall not be accepted. The bids shall be opened on the same day at 11:30 AM.
- 4. Scanned copy of Bid Security of Rs. 100,000/- (refundable) in the shape of deposit at call or a bank guarantee issued by a scheduled bank in the name of Director General PITAC, Lahore be sent through EPADS, while the original Bid Security must be dispatched to the undersigned. Bid, without earnest money will be rejected. The successful bidder will deposit performance warranty @ 10% of the total amount, which will be retained for the whole period of contract (01 year).
- 5. The bids of any bidder shall be declared non-responsive, if he is found involved in litigation with any government or semi-government department.
- 6. The bidders should be on active taxpayers list of FBR, Income Tax and Sales Tax Registration Certificate will be attached.
- 7. Successful bidder will be responsible for complete delivery, installation, and handing over of operational machine, on their own expenses at PITAC HQ, 234-Ferouzpur Road Lahore-54600.
- 8. The bidder will provide after sales service for a period of 01 year at his own cost after completion of work.
- 9. The delivery period will be 30 days (including holidays) after the issuance of Work Order. In case, the supply is not completed in the stipulated delivery period, PITAC reserves the right to short close/cancel purchase order and/or recover liquidated damages charges. The Late Delivery Charges at the rate of 0.2% per day subject to the maximum of 10% will be charged on the value Work Order/Contract amount.
- 10. PITAC reserves the right to reject all bids as per rule 33 PPRA 2004.
