QUOTATIONS

- Quotation will be provided on proper letter head pad of the firm and each page of the quotation must bear firm's stamp and signature.
- Firms will be bound to provide item/ store within time.
- Quotation received after due date will not be considered.

RESTRICTION

- CUTTING OR OVERWRITING** in the quotation must be avoided which makes it liable to rejection.
- The purchaser retains the authority to **REJECT** any or all the quotation at any time on valid grounds, which will be communicated to supplier / contractor concerned, if requested.
- The store (s) / item (s) should be exactly in accordance with the specification / sample.

TENDER OPENING

- Quotation must be dropped in the tender box before 0930 hours on 25 Mar 2025.
