Gilgit-Baltistan Disaster Management Authority (GBDMA) under UNDP GLOF-II Project invites sealed tender/bids from all interested contractors/firms to participate in execution of following works at **Parishing & Rupal Valley District Astore Gilgit Baltistan** for the year 2024-2025.

Mandatory Requirements for Eligibility for Issuance of Tender Form:

1. Valid PEC Registration Certificate valid for current financial year with relevant category and codes of specialization.
2. CE04 (vii) (Flood Control Systems Only)
3. CE10 (i) (General Civil Engineering Works)
4. Attested latest profile of the Contractor
5. CNIC of the prospective bidders
6. Affidavit of No litigation & No blacklisting (Original)
7. Required bid Security (CDR) from scheduled bank of Pakistan.

The Location & Deadlines are as under:

- i. **Location:** Office of AD GBDMA, DC Office, Astore, District Astore Gilgit Baltistan.
- ii. **Issuance:** Documents will be issued from **07 June 2024 to 28th June 2024 up to 11:30 Am**
- iii. **Submission:** Last date & timing will be **28th June, 2024 at 12:00 PM**
- iv. **Opening:** Will be opened on **28th June, 2024 at 12:30 PM**

Method of Procurement:

Single Stage Two Envelope (SSTE). (PEC Harmonized with GB PPRA Rules).

Terms and Conditions:

- a. Under following conditions bid will be rejected: -
 - i. Conditional and telegraphic bids/tenders.
 - ii. Bids not accompanied by bid security and form.
 - iii. Bids received after specified date and time.
 - iv. Bids of black listed firms.
 - v. Unsealed bids or wrongly marked bids (Technical and Financial).
- b. The Tender Documents /RFP containing detailed terms and conditions, method of constructing/supply procedure for submission of bids, bid security, bid validity, opening of bid, evaluation criteria, clarification/rejection of bids, performance guarantee etc. can be obtained from the Office of AD GBDMA Office Astore.
- c. Have experience in execution of **at least 2x similar Projects.**
- d. If any member of the Procurement Committee remains out of head quarter on date of opening of tenders, the same will be opened on the next working day at the same time as mentioned above.
- e. Firm must have bank balance of at least **25%** of the value of the project or have bank credit line of at least **50%** of the project Cost.
- f. In case of any conflict, GB PPRA Rules 2022 shall be major rule having effect on all rules.
- g. Rates quoted below 5% & 5% of the technical sanction (TS) shall be considered as



unworkable and rejected.

- h. In case of JV agreement, proper format duly signed by all partners of JV clearly mentioning share of each partner lead and associate partner duly attested by Magistrate 1st Class shall be mandatory.
- i. Bid security as specified in shape of CDR/TDR from any schedule Bank of Pakistan and "AA" rating Insurance Company.
- j. Procurement/Supply/Construction shall be carried out in accordance with the policy and guidelines issued from time to time by the GBDMA.
- k. The prospective eligible bidders may obtain bidding documents after payment of price of bidding documents and by submitting a written application personally or through an authorized representative with duly attested copy of power of attorney. Power of attorney for bidding should be in rupees RS: 100/- stamp paper in original mentioning the project name with employer stamp.
- l. In case of firm, list of partners/partnership deed, giving full particulars of Director/ Proprietor or other connected along with power of attorney or being sole proprietor such undertaking on affidavit is to be furnished.
- m. Undertaking on RS: 100/- affidavit (original) of no sick project.
- n. The proposals accompanied with bid security must reach in sealed envelopes by hand or through registered mail to the Office of the Assistant Director Office Astore before closing date and time as above and be clearly marked "BIDDING APPLICATION" for "Construction of Flood Protective Works at Parishing & Rupal Valley Astore".

The Procuring Agency reserves the right to reject any or all bids subject to Rule-33 of PPRA Rules, 2004 and updates. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Rule-33" of said Rules.
