1. Local Government & Rural Development (LG&RD) Department, (The “Employer”) invites sealed tenders under Single Stage One Envelops (SSOE) procedure for the work “**Construction of LG&RD Ware House at Headquarter Gilgit**” from the eligible Firms/Contractors Licensed by Pakistan Engineering Council (PEC) in appropriate category/code valid up to 30th June, 2024.
2. As per IB-Clause-2 “Eligible bidders” the Bidder must fulfill the following Eligibility criteria for participating in the bidding process:
 - a. The Bidder must have successfully completed at least one project of similar nature amounting to Rs. 10.000 Million in last five years. The Bidder has to submit the Certified True Copies (CTC) of **Start Orders** and **Completion Certificates**. The certification must be done by the issuing Authority of Start Order. **Non verified start order from the division/respective offices will not be entertained.**
 - b. The Bidder must have a Bank Balance amounting to Rs. 4.000 Million or above. The bidder must have to submit the Original Bank Statement Signed & Stamped by the Authorized person.
 - c. The Bidder has to submit an affidavit of “No Litigation” and “No any sick Projects”.
3. Constructors/Firms must submit the Bid Security in form of Call Deposit Receipt (CDR) amounting to Rs. 0.400 Million from any scheduled Bank in Pakistan along with the application. The CDR must bear the Original Signature and Stamp of Authorized persons. Scanned Copies of CDR will not be entertained.
4. Interested bidders can obtained the bid documents by submitting application comprise of the documents stated under Para#2 & 3 from the office of the undersigned during office hours by **11-06-2024** upon payment of a non-refundable fee of Rs. 3000/- (Three Thousand Only).
5. Authority letters of any kind will not be accepted.
6. The bids complete in all respect must be delivered in a sealed envelope by hand or through registered mail to LG&RD office address given below not later than **12-06-2024** at or before 11:00 AM Pakistan Standard Time. Bids will be opened on the same date and venue at 11:30 AM in the presence of Bidders who choose to attend.
7. Unbalanced quoted rates will be dealt as per rules/policy mentioned in the bid documents.
8. The Employer reserves the right to reject any or all applications as per PPRA Rules.
