



GILGIT BALTISTAN BOARD OF REVENUE

EXPRESSION OF INTEREST

The Board of Revenue Gilgit-Baltistan invites nationwide sealed proposals for the selection of firm who shall develop and deploy Management Information System (MIS) & Geographic Information System (GIS) for “**Land Record Management Information System**” project (LRMIS), under the programme Economic Transformation Initiative, Gilgit-Baltistan (ETI-GB) details are as under: -

1. **Scope of Work:**

Development of GIS based land records, development of MIS and digitization of revenue records including cadastral maps.

2. **Eligibility Criteria:**

- i. Registered with Securities & Exchange Commission of Pakistan (SECP) under the companies ordinance 1984.
- ii. Registered with Pakistan Software Export Board and Survey of Pakistan.
- iii. Registered with FBR for Income Tax and must be FBR’s Active Taxpayers List.
- iv. Financial capability of firm over PKR 100 million per annum.
- v. Submit a self-declaration for not being under legal action for corrupt or fraudulent practices (blacklisted) by any government organization.
- vi. Successfully developed & deployed at least three software projects, each worth of Rs. 30 million in the government sector/private sector.
- vii. For inexperienced/new firms MoU/JV or agreement with a firm fulfilling the above-mentioned criteria.

4. **Submission of Application (EoI)**

- i. EoI must be delivered in sealed envelopes by hand or through registered courier services to the undersigned on or before 08-07-2024 at 1100 hrs and clearly be marked “EOI” for “**Land Record Management Information System**” project (LRMIS)”.
- ii. EoIs received after due date and time will be rejected.
- iii. Bidding documents (REOI) can be obtained from the office of the undersigned during office hours 8:00 AM to 4:00 PM on working days upon producing a treasury slip with deposit of PKR 7,000/- (Seven thousand only) non-refundable.
- iv. EoIs will be opened on 08-07-2024 at 1130 hrs in the office of Secretary Board of Revenue Government of Gilgit Baltistan.
- v. Firm shall be engaged via quality & cost-based selection (QCBS) as provided for under the PPRA rules.
