- i. Detailed Terms & conditions are mentioned in RFP Document.
- Single Stage Two Envelope Bidding procedure will be adopted, as per Rules 36(b) of the PPRA Rules.
- It is mandatory for proposals to be prepared using standard forms of the RFP Document issued by SEPCO.
- iv. The prices should be firm and final without involving any foreign exchange.
- v. Bid Security equivalent to Rs.500,000/- (Rs. Five Hundred Thousand only) should be placed in the Technical Proposal.
- vi. Copy of registration with Sales Tax Department should be produced at the time of issuance of tender documents.
- vii. RFP Document can be obtained from the office of HR & Admn: Director SEPCO, Admn Building Thermal Power Station Old Sukkur alongwith Demand Draft / Pay order in the name of Chief Executive Officer SEPCO Sukkur against non refundable amount of 2000/- (Rupees two thousand only) on any working day during office hours, till a day earlier from the opening of the proposals.
- viii. There will be no sale of RFP Document on the date of opening of proposals.
- ix. RFP Document will be received manually and dropped in the tender box before the deadline of submission of proposals. SEPCO will not be responsible for RFP Documents received via courier / post after opening date & time.
- x. The bidders must ensure that their bids/ proposals are dropped in the tender box well in time.
- Conditional offer will not be accepted.
