- MEPCO invites sealed bids on **Single Stage-Two Envelope** bidding procedure, from eligible firms under National Competitive Bidding (NCB) basis in accordance with Provisions of PPRA Rules.

ELIGIBILITY CRITERIA

- This Invitation for Bids is open to all Bidders complying the following requirements: -
- Pakistan Engineering Council valid certificate with at-least Category **C-5** having Specialization Code **CE-10** must be provided.
 - The bidder shall be in the active tax payer list (ATL) and will provide income returns for last three years.
 - The bidder must have completed at least one contract of similar nature in last five years, (Similar nature means frame structure boundary mixed with bricks) and submit completion certificate as sole contractor or part of joint venture. The amount of work order (either as sole contractor or joint venture) of single completed project must be minimum 60% of estimated / BOQ cost. However experience as sub-contractor will not be valid.
 - The joint venture is allowed. However joint venture must be registered at concerned forum and must have joint Bank Account and joint NTN No. for taxation and financial transactions etc.
 - The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
 - Identity Card of Contractor / Managing Partner / Director of the firm.
 - Bidding documents will be issued only to the owner of the firm OR representative holding authority letter of the firm.
- Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of **Project Director (GSC) MEPCO, Multan up-to 29.11.2024** for tender.

- A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee of **Rs.3000/- (Rupees Three Thousand Only) for each tender.**
- All bids must be accompanied by a Bid Security amounting to **Rs. 1,050,000/-** for tender No.1 and **Rs:900,000/-** for tender No.2 in favor of **Project Director GSC MEPCO** of any scheduled bank and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
- The bids will be opened at the office of **Chief Engineer (Dev.) PMU MEPCO Multan** in the presence of bidders / bidder's authorized representatives who choose to attend the tender.
- Tender rates and amounts should be filled in figures as well as in words. Tender documents should be signed as per general directions given in the tender documents.
- All the procurement will be done according to PPRA Rules-2004.
- Conditional / Electronic Bid shall not be permitted.
- The bids covering partial and incomplete work shall be rejected.
- The contractor having two or more works in hand which are yet not completed and are beyond the stipulated time limit on the part of contractor, in GSC MEPCO will not eligible to participate in the tender. Bidder will submit certificate issued by Project Director (GSC) office MEPCO Multan.
- All the bids along-with relevant documents received without binding with tender book will not acceptable.
- The bidder will submit two copies of the bidding documents i.e. one will be original and 2nd will be photocopy.
- All the pages of tender will be marked as page No. and each page must be signed and stamped by the bidder.
- A certificate will also be submitted with bid documents mentioning that "the tender documents consists of page No.1 to Pages
