1. The National Highway Authority (NHA) intends to hire/ engage a Consultant (Organizations/ Firms/ Companies) for Tax Consultancy Services on monthly retainerhip basis.
2. Proposals are invited from reputable Consultants (Organizations/ Firms/ Companies) having valid registration certificate from concerned departments alongwith enlistment on Active Tax Payers list of Federal Board of Revenue and the detail eligibility criteria mentioned in the RFP document.

RFP documents can be downloaded from NHA's website www.nha.gov.pk free of cost or the same can be purchased from the office of General Manager (P&CA), NHA-HQ, Islamabad during working hours and working days on written request of firm's letter head accompanied with pay order/demand draft amounting to Rs.1,000/- (nonrefundable) in favor of National Highway Authority.
