


**Government of Pakistan

Ministry of Foreign Affairs, Islamabad invites sealed bids from reputed Contractors/firms registered with Pakistan Engineering Council (PEC) for the year 2023-2024 in category C-5 or above with relevant code of work for below mentioned work:

2. Bidding will be carried out by adopting "**Single Stage Two Envelope (SSTE)**" procedure as per Clause-36(b) of Public Procurement Rule-2014.
3. In the first instance, technical proposal shall be opened and evaluated **as per criteria** given in bidding documents i.e. (TORs).
4. After the technical evaluation and approval of the proposal, the Ministry of Foreign Affairs will open the financial bids only of the technically responsive bidders on the date, time and venue communicated later.
5. Pre-bid meeting will be held on **24 July 2024 at 1100 Hours** in Conference Room, 3rd floor, Agha Shahi Block, Ministry of Foreign Affairs, Islamabad.
6. The bidders shall bid for complete scope of work as specified in bidding documents. Incomplete bids or bids covering partial scope of work will be rejected.
7. All bids must be accompanied by a bid security in the shape of irrevocable CDR of the quoted bid price in the name of Ministry of Foreign Affairs, Islamabad.
8. Bidding documents can be downloaded from EPADS free of cost.
9. Bids, prepared in accordance with the instructions provided in the bidding documents, must be submitted **electronically through EPADS only and original Bid Security must be submitted (in hard form)** through legally authorized representatives only **on the address given hereunder on or before 05 August 2024 at 1300 hrs.** Technical proposals shall be opened on same day at 1330 hrs.
