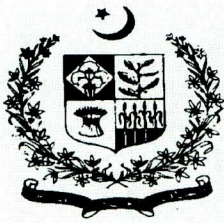

The Directorate General MIS, department of the Controller General of Accounts (“The Employer”), invites bids on EPADS from eligible firms or persons licensed by the Pakistan Engineering Council in the respective specialization category for executing each engineering works up to Rs.10 Million or above and having considerable experience of managing similar type of services in other specialized organizations preferably in IT organizations/Data Centre Management firms, for “**Procurement of Operations & Maintenance Services with spare parts for 08 FABS Mini Server Rooms (Wall Mounted, Tower ACs, Precision Cooling Systems, UPSs, Generators and Fire Suppression System)**”. The firm will be hired for one year according to principal procurement method of open competitive bidding under PPRA Rules 2004 Sub Rule 21 subject to fulfilling bidder’s qualification, technical, financial bids evaluation criteria’s, coherent compliance of bid solicitation documents RFB-42, PPRA’s and Government regulations. **Active Registration with Pakistan Engineering Council and EPAD portal of PPRA is mandatory.**
2. A complete set of bidding documents may be downloaded free of cost from EPADS. A bid security equivalent to 2% of the total estimated bid price be submitted against O & M Services only in the form of pay order in favor of **DDO, Directorate General MIS,CGA** by an interested eligible bidders on given below address prior to bids opening on EPADS. All bids must be submitted alongwith **Bid Security** amount of 02% of the total estimated bid price (unit price of Annex-D items) quoted by the bidder in favor of **DDO Directorate General MIS, CGA** through pay order/demand draft/bank guarantee or CD-R and must be delivered to the undersigned at given below address on or before **11:00 A.M, 29-07-2024 (Monday)**. **Technical and financial bids of bidders will be opened on EPADS by same day 11:30 A.M (Monday) at Committee Room, FABS Directorate, 2nd Floor, O/o the AGPR, Sector G-8/4, Islamabad in presence of bidders or their authorized representatives on the basis of “Single Stage-one envelope procedure” of PPRA Rules 2004 and evaluation according to the Quality & Cost Based Selection Method-QCBS of Federal PPRA Consultancy Services Regulations 2010.**

Bidders are requested to quote their bid price alongwith breakup of Operations and Maintenance Cost comprises, maintenance cost, employment cost, other associated costs headings separately mentioned under Price Schedule at Annex-D with isolated value of relevant taxes in compliance to FBR Regulations. Conditional, delayed and non-responsive bids will be straight away rejected on spot as per PPRA Rules.
