

1. Office of **AGE (Army) Defence Complex Islamabad** invites sealed tenders for the following works in the light of PPRA Rule 13 (1) of 2004.

2. The Contractor are required to submit their application for issuance of tender documents along with their complete credentials as shown at serial (3). The application shall be scrutinized and the tender documents will only be issued to the firms who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. Tenders will only be issued to the scrutinized contractors. The tenders must be received in the office of the Accepting Officer by **1130 hour** by **29 Aug 2024** and tender will be opened on **29 Aug 2024 at 1200 hours.**

**NOTE:-** Contractor shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ Rwp) is outstanding against them.

3. Firms / Contractors not borne on approved list of MES may also apply and they will deposit earnest money @ 2% of estimated cost and will furnish a certificate along with their applications, giving details of works executed during last two years and those in hand on the proforma appended below:-

4. All contractors will certify in writing that they are registered with Pakistan Engineering Counsel (PEC), and will be submit a copy of their registration.

5. Contractor born on approved list of MES in Category **A, B, C, D & E** and also having experience of this type should only apply.

6. The accepting officer reserves the right to accept or reject the tender, Rejected tender will be dealt with as per Para 33 (i) of PPRA Rules.
