- iii. Single stage two envelope procedures under PPRA rules will be adopted for tender evaluation.
- iv. Technical and Financial Proposals should be submitted in separate envelopes, the words 'Technical Proposal' or 'Financial Proposal', as the case may be, and **Tender No:11/1/2024/ORACLE/LOGISTICS**, being clearly written on the top of the respective envelope and both 'Technical and Financial Proposal' should be in one envelope.
- v. In the first instance, Technical Proposals shall be opened by a committee on **January 31st, 2025, at 03:00 PM.**
- vi. In the Conference Room of this office. After technical evaluation, **Financial Proposals of only technically qualified companies shall be opened on a date/time to be announced subsequently.**
- vii. A tender security in original amounting to **Rs.280,000/-** must be attached with the Financial Proposal in the form of a Pay Order/Demand Draft/Bank Guarantee in favor of Directorate General Immigration & Passports. Copy of bid bond will be attached with technical proposals.
