

## FOR THE PROCUREMENT OF DAL CHANA (SMALL GRAIN) THROUGH E-PADS

The Utility Stores Corporation of Pakistan (USCP), Ministry of Industries & Production, invites sealed bid/ offers under Rule 36 (a) "Single Stage One Envelope" bidding procedure of the Public Procurement Rules, 2004 for the supply of Dal Chana (Small Grain) in net weight of 50 Kg polypropylene bags from Suppliers, firms, company, organization, stockiest, Traders (the Supplier), who are financially sound, registered with Federal Board of Revenue for Income Tax/GST (Registered) and who are on Active Taxpayer List (Income / Sales Tax) of the Federal Board of Revenue / relevant tax authorities, for the on FOR (delivered basis) along with 5kg, & 1/2 kg, separately packed sample through E-PADS.

The required quantity of Dal Chana (Small Grain) to be procured is mentioned in the bidding document, which must be delivered to each specific / respective Station. Sealed bid should be uploaded and required to reach electronically on E-PADS by **30.01.2025 at 12:00 PM** which will be opened on the same day at **12:30 PM** in the presence of bidders or their authorized representative who may wish to attend. In case of opening of bids falls on local/national holiday, the date of bid closing/opening shall be the next working day on the same time and venue. All interested bidders must register themselves with on E-PADS and submit bidding documents. No physical bid shall be entertained.

The bidders are required to give their best and final prices (including all applicable taxes). Bids not complying with the requirements shall be rejected being nonresponsive. Alternate / conditional/ incomplete bids shall be considered nonresponsive. Taxes will be deducted as per applicable Government Rules. NTN/Sales Tax Registrations certificates must be provided with the bid.

Bids which are incomplete/not scaled/not signed / not stamped/late or submitted by other than specified mode will be rejected. The contract will be awarded to the most advantageous bid on item/ commodity wise lowest quoted rates.

Bid must be accompanied with a sample of Dal Chana (Small Grain) of not less than 5 Kg & 1/2 Kg separately at the time of opening of Bids, which will be considered as part of the bid in the quantity required the sample shall be properly marked and be sent to the designated lab through Quality Assurance Department in accordance with the SOP's issued by Quality Assurance Department USCP. In case the sample is not found as per specifications, the bidder shall be disqualified for being, non-responsive as the sample is deemed as essential / integral part of the bid.

Bid/Tender documents along with terms and conditions for bidding can be obtained from electronically and can be downloaded from USCP website, i.e. www.usc.org.pk as well as E-PADS PPRA website www.eprocure.gov.pk free of cost. Bidders need to register themselves at E-PADS PPRA to access the bidding documents and other relevant information. The tender fee of Rs. 2,000/- must reach USCP Head Office in shape of Pay Order/Bank Draft in lieu of provision of bidding documents, at the time of opening of bids.

An affidavit on legal stamp paper worth Rs.100/- to the effect that the bidder has not been blacklisted by any Govt/Semi Govt/Autonomous Organization and there is no litigation lying pending adjudication in any Court of law.
