## **TERMS & CONDITIONS**

- 1. The tender shall be granted on the basis of competitive bidding process, as is embodied in Public Procurement Rules, 2004.
- 2. The bidder should be registered with Income Tax, Sales Tax having their own office & Phone / fax number (if found contrary, the tender will be rejected).
- 3. The bidders should not have been black-listed by any authority in the past.
- 4. The tender documents can be obtained from the General Branch of this Collectorate during any working hours / day.
- 5. The bidders are required to furnish security deposit of 5% of total amount in the shape of pay order or demand draft from a scheduled bank in favor of Collector, Collectorate of Customs Appraisement (West), Lahore. The security deposit shall be refundable to the unsuccessful bidder(s). The security deposit shall be returned to the successful bidder on completion of the tender contract.
- 6. The price shall be offered in local currency and include all duties / taxes and the expenses incurred on supplies including transportation, labor etc. where required up to 30-06-2025.
- 7. The tender bid must mention the type of warrantee and after sale service, if any.
- 8. Sealed tender bids on prescribed tender documents must be delivered to the address given below on 02.06.2025, before 1100 hours and the same shall be opened at 1200 hours on the same day in the presence of the participants of the tender or their authorized representatives who desire to attend.
- 9. Bidders shall quote their final prices both in figures and in words, any cutting / over-writing and correction in the tender form will not be accepted.
- 10. Bidders are required to give complete description, catalogue of items along with samples of their offers.
- 11. The tender bid must be valid for up to 30.06.2025, after opening of tenders.
- 12. Payment will be made on the basis of verification / inspection by concerned staff and subsequent report submission.
- 13. The quantity of items to be purchased can be increased or decreased.



- 14. All items will have to be supplied strictly as per specifications mentioned in the tender form within prescribed time & date of the issuance of purchase / supply order.
- 15. Attested copies of Sales Tax Registration and NTN must be attached with the bid.
- 16. Samples of the material major items must be accompanied with the bid for evaluation and comparison with other bidders by the Purchase Committee.
- 17. Procuring agency reserves the right to reject all bids or proposals at any time prior to the acceptance of bid or proposal. The procuring agency shall communicate the bidder for its rejection, but is not required to justify grounds for rejection.
- 18. No bid shall be entertained after given cut-off date and time.

19. The procuring agency shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least three days prior to the award of procurement contract. A copy of the result shall be placed on the notice board of Collectorate of Customs Appraisement (West), Lahore.
