5. Contractors borne on the approved List of MES in category 'A', 'B', 'C' & 'D' having experience of this type of work may only apply.

6. Contractors who desire may be present at the time of opening of tenders.

7. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules
